I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that an ORDER OF SALE did issue out of the Superior Court of SKAGIT County, Washington, on April 17, 2017, upon a judgment rendered in Superior Court of SKAGIT County, Washington on March 3, 2017, in favor of U.S. BANK NATIONAL ASSOCIATION, AS TRUSTEE FOR STRUCTURED ASSET INVESTMENT LOAN TRUST, MORTGAGE PASS-THROUGH

CERTIFICATES, SERIES 2005-7, for the sum of Two Hundred, Ninety-One Thousand, Two Hundred a Eighty Dollars and Forty One Cents (\$291,280.41).
