## **COMMUNITY PROPERTY AGREEMENT**

THIS AGREEMENT is made by and between EARNEST BEVIL GRANVILLE and ELAINE EDITH MARIE GRANVILLE, husband and wife ("the Spouses'), both of whom are domiciled in the State of Washington. In consideration of their mutual agreements set forth below, the Spouses hereby agree as follows:

- A. <u>Status of Property</u>. This agreement shall apply to all property listed in this Paragraph A, whether real, personal, or mixed and wherever located; which property shall be considered and hereby is declared to be the community property of the Spouses, regardless of whether it is titled in the name of either Spouse or both spouses:
- (1) All tangible personal property now owned or hereafter acquired by either or both spouses. "Tangible personal property" shall include but not be limited to automobiles, boats, airplanes, household goods, furnishings, appliances, silverware, cooking utensils, dishes, paintings, pictures, books, collections, sporting equipment, jewelry, and clothing and personal effects. The term shall not include interests in real estate, mobile homes, money, bank accounts, securities, or intangible property.
- (2) The real property commonly known as 4814 Harbor View Place, Anacortes, Washington, legally described as follows:

- (3) The Wachovia Securities Account registered in the name of Earnest B. Granville at the time that this agreement is executed with an account number ending in 8907.
- B. <u>Disposition of Property</u>. Upon the death of one of the Spouses survived by the other Spouse, all the then-existing community property of the Spouses, real and personal, shall vest in and become the sole property of the surviving Spouse in fee simple.
- C. <u>Termination</u>. This Agreement may be terminated upon mutual, written agreement of the Spouses or their acting Attorney(s)-in-fact. In the absence of other evidence

indicating the Spouses' intent to terminate this Agreement, it shall, nevertheless, be deemed mutually terminated and of no further force or effect upon the occurrence of one or more of the following events:

- (1) Upon either Spouse filing a petition, complaint, or other pleading for legal separation, dissolution of the marriage, or to have the marriage declared invalid.
- (2) Immediately prior to death if both Spouses should die simultaneously or under circumstances where the order of death cannot be ascertained.
- D. <u>Disclaimer</u>. Upon the death of either Spouse, the surviving Spouse may disclaim any interest passing under this agreement in whole or in part, or with reference to specific parts, shares or assets thereof, in which event the interest disclaimed shall pass as if the provisions of paragraph B had been revoked as to such interest, with the surviving Spouse entitled to the benefits provided by any alternate disposition.
- E. Revocation of Contrary Provisions. The provisions of any community property agreement, agreement regarding the status of property, or any other arrangement made previously by the Spouses or either of them affecting the property described in this Agreement are hereby revoked to the extent of any inconsistency with this Agreement.

### Death Certificates

Proof is required to make changes if requested by a family member not listed as the informant on the pertilicate (tamily members are spouse or registered domestic partner, parent, sibling or adult child or stepchild). The informant may change marital status with proof. Marital status requires a certified copy of a court order if someone other than the informant is requesting the change.
- The medical information (cause of death) may be changed only by the certifying physician or the coroner/medical examines

Marriage/Dissolution (Divorce) Certificates

- Personal facts (minor spelling changes in name, date or place of birth or residence) may be changed by the person with one piece of decimentary proof
- To change the date or place of marriage or dissolution, the officiant (marriage) or clerk of court (dissolution) must complete and submit the affidavit
