MEMORANDUM OF PURCHASE RIGHT

CHIS MEMORANDUM OF PURCHASE RIGHT (this "Memorandum") is executed as of this __day of April, 2018, by SEAFARER'S, LLP, a Washington limited liability partnership ("Seafarer's") and DUANE CLARK, an individual ("Clark").

RECITALS

- A. Seafarer's and Clark are parties to that certain Loan Agreement of even date herewith (the "Loan Agreement"), pursuant to which Seafarer's has granted to Clark the right to purchase (the "Purchase Right") a portion of the real property and improvements thereon or to be built thereon situate in the City of Anacortes, County of Skagit, State of Washington, and more particularly described in Exhibit A attached hereto (the "Property").
- B. Seafarer's and Clark desire to execute and record this Memorandum to give record notice of the Clark's Purchase Right.

AGREEMENT

The sole purpose of this Memorandum is to give notice of the Purchase Right. Pursuant to the Purchase Right, Seafarer's has granted Clark a right to purchase the Property, or a defined portion of the Property. Clark's Purchase Right shall survive the termination or expiration of the Loan Agreement and repayment of the indebtedness described therein. If Clark fails to timely exercise the Purchase Right pursuant to the Loan Agreement, the Purchase Right will terminate with respect to the Property (or a defined portion of the Property) after the Exercise Date (as such term is defined in the Loan Agreement), provided that Seafarer's has provided Clark with sufficient notice of the Exercise Date as specified in the Loan Agreement. This Memorandum does not amend or alter the terms of the Purchase Right as set forth in the Loan Agreement. In the event of a conflict between this Memorandum and the Loan Agreement, the terms of the Loan Agreement shall control.

This Memorandum may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
