DECLARATION OF EASEMENT FOR UTILITIES AND ACCESS

WHEREAS, Hoyer Homes LLC is the owner Parcels A1, C1, D1, E1 and F1 of Survey AFN 201706160061, records of Skagit County, Washington,

WHEREAS, the access to Parcels C1, D1, E1 and F1 is over that portion of Hoxie Lane that lies within the Parcel A1; and

WHEREAS, utility equipment to serve Parcels C1, D1, E1 and F1 is or will be located within Parcel A1 near Hoxie Lane;

NOW THEREFORE: Grantor for himself, his heirs, future owners, successors in interest and assigns of the property does hereby grant, convey, establish and create a permanent easement for the placement and replacement maintenance and monitoring, construction, reconstruction, repair and upkeep of utility equipment which serves Parcels C1, D1, E1 and F1 now and in the future, including the cutting and removal of brush, trees and other obstructions which interfere with the use of said easement, together with the rights of ingress, egress, over, under, along and across portions of the Parcel A1 as reasonably necessary.

In addition, Grantor does hereby grant, convey, establish and create a non-exclusive access easement together with the rights of ingress and egress over, under, along and across that portion of Parcel A1 currently known as Hoxie Lane as it is now located and where it may be located in the future. The responsibility for maintenance of the easement within Parcel A1 shall be evenly shared by the owners of Parcels A1, C1, D1, E1 and F1 as described above.
