11	3.3 Plaintiff shall be permitted to be a purchaser at the sale; that the net proceeds of said sale be applied first toward the payment of the costs of said sale and then towards the payment
12	of Plaintiff's judgment
13	3.4 Plaintiff waives any deficiency judgment against Defendant.
14	3.5 After the sale of said property, all right, title, claim, lien or interest of the Defendant, and of every person claiming by, through or under the Defendant, in or to said property, including the right of property and offere said the form and
