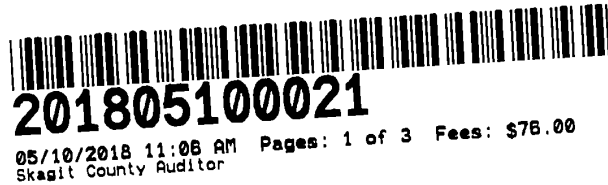

MEMORANDUM OF LEASE

EXCEPT that certain strip of land 17 feet wide at the West end and 24 feet wide at the East end lying along and adjacent to the South line of the Southwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ of said Section 25 as conveyed to Skagit County by deed recorded March 10, 1902, under Auditor's File No. 39095, in Volume 46 of Deeds, page 307 records of Skagit County, Washington,

ALSO EXCEPT drainage ditches rights-of-way as condemned in Skagit County Superior Court Cause Nos. 3062 and 3604,

AND ALSO EXCEPT the as-built and existing county roads running along the West and South lines thereof commonly known as the Avon-Allen Road and Maiben Road.

Said Lease is for a period of four (4) years ending December 31, 2021 and includes a First Right of Refusal to renew this Lease further described in the AGRICULTURAL LEASE between Landlord and Tenant.

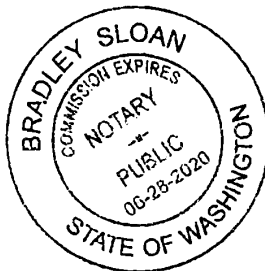

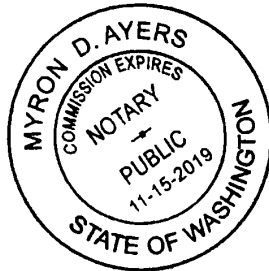


