I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that a Writ for Order of Sale did issue out of the Superior Court of SKAGIT County, Washington, on February 19, 2016, upon a judgment rendered in Superior Court of SKAGIT County, Washington on July 10, 2015, in favor of PNC BANK, NATIONAL ASSOCIATION, its successors in interest and/or assigns, for the sum of Three Hundred Ninety-Three Thousand, Eight hundred Seventy-Eight Dollars and Eighty-Five Cents (\$393,878.85).

The Writ for Order of Sale, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on February 29, 2016, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the Writ for Order of Sale.

The Sheriff did, in obedience to the Writ for Order of Sale, levy upon the real property described below, and on April 15, 2016, sold the real property at public auction, for cash in hand, at the front door of the Skagit County Courthouse, 205 W. The Sheriff thereupon delivered to said purchaser a Certificate of Sale as required by law and on June 24, 2016, the above entitled court in its order made and duly entered, confirmed said sale.

Any further possible redemption of the real estate, as of this date, has expired.
