- The owners of the lots herein described shall share on an equal basis all expenses for maintenance, upkeep and repair of the driveway.
- 2. The driveway is to be maintained in a condition that will allow for unimpeded vehicular access.
- 3. All decisions concerning maintenance, repair or upgrading the existing driveway easement shall be unanimous by all owners of said lots and each lot shall have one vote.
- 4. The terms and provisions of this maintenance agreement are binding on all successors, and assigns and the covenants contained herein shall run with the land.
- 5. Should it be necessary for the owner of any lot to refer this agreement to an attorney for purposes of enforcement, any owner who is deemed to be in default shall be obligated to pay the prevailing party's costs and attorney's fees, as well as any shared costs for such maintenance, upgrade or repair.
