PRIVATE ROAD MAINTENANCE AGREEMENT

RECITALS

WHEREAS. _Maple Ave, Lyman WA (the "Roadway") is a private road and easement or right-of-way situated in the area of the County of Skagit. The parties desire to enter into an Agreement regarding responsibilities for maintenance of and improvements to the Roadway.

NOW THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

- (1) **Mutual responsibility.** The responsibility for the construction, repair, and maintenance of the Roadway serving the parcels shall be shared equally among the owners of said parcels served by the Roadway.
- (2) **Good repair.** The Roadway shall be constructed and maintained as a gravel road sufficient for vehicular traffic, with maintenance to include, without limitation, mowing, grading, scraping, ditching, snow removal, spreading of new gravel, and/or placement of new pavement, whenever deemed necessary by the owners.
- (3) **No public responsibility.** Said construction and maintenance is under no circumstances a responsibility of the County or any other public entity.
- (4) **Equal responsibility.** Road maintenance, snowplowing, and road improvement costs shall be shared on an equal basis between the parcel owners sharing access to the above-mentioned road.
