The water shares of the abovereferenced tracts 5 and 6 are hereby revoked, with such revocation being by and with the consent of the owners of tracts 1, 2 3 and 4, and also by and with the consent of the owners of tracts 5 and 6, and the owners of tracts 5 and 6 shall hereafter have no further shares.

Except as changed above, the Supplemental Agreement as to Water System Operation and Maintenance Community of Taggart Quarry Declaration of Easements, Protective Covenants and Well Maintenance Provisions recorded under Skagit County Auditor's File number 200004180025 remains in full force and effect.
