## AMENDMENT TO DECLARATION OF EASEMENTS, PROTECTIVE COVENANTS AND ROAD AND WELL MAINTENANCE PROVISIONS

The undersigned, being the owners of four of the six parcels identified in the Declaration of Easements, Protective Covenants and Well Maintenance Provisions recorded under Skagit County Auditor's File number 9607150132, and acting with the approval and consent of the owner of the other two of the six parcels identified in that Declaration, which consent was given with a certain Agreement to Release Property from Rights and Obligations of Well

AMENDMENT TO DECLARATION OF EASEMENTS, PROTECTIVE COVENANTS AND ROAD AND WELL MAINTENANCE PROVISIONS Page 1 of 7 Agreement as among all six parcel owners and effective on April 16, 2018, hereby amend that Declaration as follows:

Paragraph 6 is changed to read as follows:

6. That prior to the incurring of expenses for the maintenance, repair and/or replacement of the road referred to above, at least thirty days written notice to all owners of the property shall be required and no expense shall be incurred unless the owners of at least four (4) parcels agree to the expenditure, and that prior to the incurring of expenses for the maintenance, repair and/or replacement of the community well and its associated water system, at least thirty days written notice to the owners of parcels 1, 2, 3, and 4 shall be required and no expense shall be incurred unless the owners of at least three (3) of those four parcels agree to the expenditure. This notice requirement shall not be required in the event of an emergency and in that event, the property owner or owners incurring said expense shall give immediate notice to the other owners of said expenditure. The parcel owner(s) paying for the work may then seek reimbursement from the other property owners for their respective share. The amount of said reimbursement shall bear interest at the highest legal rate of interest commencing thirty (30) days from the date notice is given until paid.

Paragraph 7 is changed to read as follows:

7. The community water well established by Declarant on parcel 1 of the property for the purposes of supplying water for domestic purposes to the six parcels which comprise the property shall now be used for supplying such water to only parcels 1, 2, 3, and 4, and parcels 5 and 6 are hereby removed from the benefits and obligations associated with that well and its system. However, the easement granted, quit claimed and conveyed by Declarant from the well to the road referred to in paragraph 2 above remains effective for the purpose of a water pipeline for purposes of maintenance, repair and replacement of such waterline as shall be necessary.

Paragraph 8 is changed to read as follows:

8. The owners of parcels 1, 2, 3, and 4 shall maintain the community water system in accordance with all applicable laws, AMENDMENT TO DECLARATION OF EASEMENTS, PROTECTIVE COVENANTS AND ROAD AND WELL MAINTENANCE PROVISIONS Page 2 of 7

rules and regulation as established by Skagit County and the State of Washington.

Paragraph 9 is changed to read as follows:

9. The owners of parcels 1, 2, 3, and 4 shall each be responsible for one-fourth (1/4) of the expenses connected with the supplying of electrical power to the well, its maintenance, repair and/or replacement in the same manner as provided in paragraph 6 above. All expenses incurred for the construction, maintenance, repair and replacement of water pipelines to the parcels shall be the responsibility of the owners of the parcels being served by said water pipelines.

Paragraph 10 is changed to read as follows:

10. The owners of each parcel shall have one vote for each parcel of property. In the event the owners of two parcels of the property elect to combine their parcels into one parcel, the payment of expenses associated with the road would be prorated on a one-fifth (1/5) basis, but no combination of parcels 1, 2, 3 and 4 shall affect the proration of the one-fourth (1/4) allocation of those parcels to the payment of expenses associated with the well and water system.

Except as changed above, the Declaration of Easements, Protective Covenants and Well Maintenance Provisions recorded under Skagit County Auditor's File number 9607150132 remains in full force and effect.
