This Deed of Trust is for the purpose of securing payment to the Beneficiary and/or Trustee, of the monies due to and all losses, damages, expenses and liability suffered, sustained, made or incurred by or on behalf of the Surety (and as more fully set forth and described in a certain Indemnity Agreement For Surety Bail Bond, which agreement is made a part hereof by reference as though herein fully set forth) on account of, growing out of, or resulting from the execution of a certain bail bond(s) on behalf of Soto-Ceja, Joel in the matter of State of Washington vs. Joel Soto-Ceja (#150,000) and for which amounts and the matters set forth in the Indemnity Agreement, the presents are security, (Bond # AC150-7078139) (Bond # _____) (Bond # _____) (and any additional bonds executed in connection with the defendant relating to the above-entitled matter).
