### FIRST AMENDMENT TO TRANSFER AGREEMENT

OID: 00-36 (Raspberry Ridge I Apartments)

Washington State Housing Finance Commission Low Income Housing Tax Credit Program

THIS FIRST AMENDMENT TO TRANSFER AGREEMENT ("Agreement") is entered into effective as of July 1, 2018, by and among the WASHINGTON STATE HOUSING FINANCE COMMISSION, a public body corporate and politic (the "Commission"); Raspberry RIDGE APARTMENTS LIMITED PARTNERSHIP, a Washington limited partnership (the "Partnership" or "Transferor"), SL RASPBERRY RIDGE LLC, a Washington limited liability company (the "Company"), and HOUSING AUTHORITY OF SKAGIT COUNTY, a public body corporate and politic of the State of Washington (the "Authority").

WHEREAS, the Commission and the Partnership entered into a Regulatory Agreement (Extended Use Agreement) dated July 1, 2018 and recorded in the official public records of Skagit County, Washington, under Auditor's File No. 201807020145; and

WHEREAS, the Commission, the Company, and Partnership entered into a Transfer Agreement dated as of July 1, 2018 and recorded in the official public records of Skagit County, Washington, under Auditor's File No. 201807020145 (the "Transfer Agreement") whereby the Partnership transferred the Project and the Property (as hereinafter defined) to the Company.

WHEREAS, the low income housing project known as Raspberry Ridge Apartments (the "Project") and the real property described on **Exhibit A** attached hereto (the "<u>Property</u>") are the sole assets of the Company.

WHEREAS, the Authority, as the sole member and manager of the Company, desires to liquidate the Company and distribute that Project and Property to the Authority.

WHEREAS, the Parties desire to amend the Transfer Agreement to recognize the Authority as the Transferee.

NOW THEREFORE, the parties hereto agree as follows:

- 1. The Commission acknowledges and consents to transfer of Property and Project by the Company to the Authority.
- 2. All references to the Assignee in the Transfer Agreement are amended to refer to the Authority.

- 3. The Authority hereby assumes and is bound by all terms, conditions and obligations of Assignee under the terms of the Transfer Agreement.
- 4. Except as otherwise provided herein, all other terms and conditions of the Transfer Agreement remain in full force and effect.
- 5. This Agreement may be executed in several counterparts, and as executed shall constitute one instrument, binding on all the parties hereto, notwithstanding that all parties are not signatory to the original or the same counterpart.
- 6. This Agreement shall be effective on the date of its execution by a duly authorized representative of the Commission.
