This Amendment to Protective Covenants, Conditions and Restrictions for River Valley View Estates is made by owners of lots subject to the Declaration (as defined below) identified on the signature page hereto (herein referred to as the "Owners"). The lots are more specifically described on Exhibit A attached hereto.

RECITALS

- A. Reference is hereby made to those certain Protective Covenants, Conditions and Restrictions for River Valley View Estates, which instrument is filed under County Auditor's File No. 2001-05070103, and recorded in the Real Property Records of Skagit County, Washington (as previously amended by instruments filed under County Auditor's File Nos. 2001-05070103, 2001-06210005, 2002-02130058, 200207190134 and 200207190135, the "Declaration"), covering certain property described therein as the "River Valley View Estates". All terms defined in the Declaration are used in this Amendment with the same meanings.
- B. Whereas Paragraph 3 of the General Provisions section of the Declaration currently provides that the Declaration may be amended at any time by the owners of not less than seventy-five (75) percent of the lots subject to the Declaration.
- C. The Owners own nine (9) out of a total of nine (9) lots subject to the Declaration, which exceeds the threshold necessary to amend the Declaration.
- D. The Owners desire to modify the Declaration such that a portion of the lot described on Exhibit B attached hereto (the "Subject Lot") may be leased by the Subject Lot's owner to a third party for the purpose of constructing, maintaining, repairing and operating a communications facility and uses incidental thereto, including, without limitation, installation of a tower structure that will provide antenna locations for the transmission and reception of communications signals and the installation, construction, maintenance, operation, repair, replacement and upgrade of communications fixtures and related equipment, cables, accessories and improvements.

ACCORDINGLY, the Owners hereby adopt, and agree and consent to, the terms and provisions of this Amendment and declare that the Declaration is amended as herein set forth.

I. AMENDMENTS TO THE DECLARATION

Any capitalized terms in this Amendment and not defined or modified herein shall have the meanings ascribed to them in this Declaration.

1. The Declaration is amended in its entirety to provide that the Subject Lot may be leased by the Subject Lot's owner to a third party for the purpose of constructing, maintaining, repairing and operating a communications facility and uses incidental thereto, including, without limitation, installation of a tower structure that will provide antenna locations for the transmission and reception of communications signals and the installation, construction, maintenance, operation, repair, replacement and upgrade of communications fixtures and related equipment, cables, accessories and improvements. The foregoing right may not be revoked, modified or limited in any way without the written consent of the Subject Lot's owner.

II. MISCELLANEOUS PROVISIONS

- 1. The terms and conditions of the this Amendment shall modify and supersede all terms and provisions of the Declaration that are in irreconcilable conflict herewith, and, except as so modified and superseded by this Amendment, the terms and provisions of the Declaration are ratified and confirmed and shall continue in full force and effect.
- 2. The headings in this Amendment are for reference purposes only and shall not in any way affect the meaning or the interpretation of the Amendment.
