By an Assignment of Lease with Consent Thereto by and between the Port of Skagit County, as Lessor, Alyeska Ocean Aviation, LLC, as original Lessee, and Corporate Air Center, LLC, dated October 18, 2010, recorded October 28, 2010 under Skagit County Auditor's File No. 201010280138, the Lessee's interest in the First Amended Lease was assigned to Corporate Air Center, LLC, a Washington limited liability company ("Assignee/Lessee"). Collectively, the Land Lease Agreement, First Amended Lease and the Assignment of Lease with Consent Thereto are referred to hereafter as the "Lease."

- 2. **Term of Lease**. The Lease is in effect now; the term of the Lease is for a period of thirty (30) years from the Commencement Date as set forth in Paragraph 2.b. of the Lease, July 1, 2008, and will terminate on June 30, 2038.
- 3. Options to Extend. There is an Option for Lessee to extend the Lease for two (2) consecutive ten (10) year option periods as described in Paragraph 2.d. of the Lease.
- 4. Lessor's Option to Buy Out Lease. Lessor is granted the right to terminate and buy out the remainder of the Lease, and the Lessee owed improvements, during the initial term or any extension pursuant to the terms and conditions stated in the Lease.
