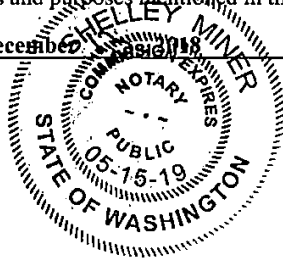

Lots 10 through 15, inclusive, Block 5, EXCEPT that portion thereof lying outside the meander line or shoreline of Bellingham Bay (the line which is farthest out shall govern);

Block 6

TOGETHER WITH all that portion of Front Street abutting Lots 10, 11 and the Northerly most part of Lot 12, Block 5, and abutting Block 6, described as: That portion of Front Street lying Northerly of the North line of Charles Street produced Easterly and lying Easterly of a line described as beginning at the most Northerly corner of Block 6, TOWN OF SAMISH; thence North to the most Westerly corner of Lot 8, Block 5, TOWN OF SAMISH; EXCEPT that portion of Front Street previously vacated to Larry Goroski and Belle Goroski on June 27, 1980, under Skagit County Cause No. 40897, abutting a portion of Lot 12; AND EXCEPT that portion abutting Lots 8 and 9 of Block 5.
