- 1. **Grantor.** I, SETH SCOTT, am the duly appointed, qualified, and acting Personal Representative of the Estate of RUBY SCOTT, Skagit County, Washington, Superior Court Case No. 05-4-00226-3.
  - 2. Grantee. The Grantee is GROW FOOD, INC.
- **3. Decedent's Estate.** VIRGIL C. SCOTT died testate on January 16, 1974, leaving his estate to his spouse, RUBY SCOTT. RUBY SCOTT died testate on December 22, 2004. On August 23, 2005, RUBY SCOTT'S Last Will and Testament was admitted to probate.

On April 8, 2014 the Court closed the probate due to inactivity.

On December 1, 2017, pursuant to a Petition to Re-Open Probate, Letters Testamentary were issued to RUBY CLEAVE as Personal Representative of the Estate of RUBY SCOTT.

On January 11, 2018, RUBY CLEAVE died. On March 21, 2018, SETH SCOTT, Grantor, was appointed Successor Personal Representative of the Estate of Ruby Scott. Mr. Scott was granted Nonintervention Powers for the administration of Decedent's estate.

- **4. Will Provision.** In her *Last Will and Testament*, Decedent RUBY SCOTT provided that her estate be devised to her children, per stirpes. On February 24, 2017 the Personal Representative sold to GROW FOOD, INC. three parcels of agricultural land (P21429, P21458, P21463) situated in Skagit County. The proceeds of the sale were apportioned among the children of the decedent, per stirpes. However, the sale should have included the one-acre parcel that is the subject of this deed (P21420).
- **5. Real Property.** The real property devised to GROW FOOD, INC is located in Skagit County, Washington and is legally described as follows:
