

- 6. PREFERENCE OF TERMS OF ADDITIONAL NOTE; MATURITY DATE AND LOAN INTEREST RATE. However, any prepayment charge provision associated with the Original Note, either according to its terms or as created by an addendum to the Original Note or a modification of the Original Note, will continue to be effective as to the Original Note, as amended and the Additional Note, as amended, as well as any other notes executed with Lender until the expiration of the terms of the prepayment language.
