This conveyance is made in consideration of this direction in the Trust.
- 4. <u>Conveyance of Described Property</u>. Grantors hereby convey and quitclaim to the **E. Cary Halpin Survivor's Trust**, E. Cary Halpin, Michael C. Halpin and Craig M. Halpin, Trustees, created pursuant to Article 6.2 of the Cary and Mo Halpin Revocable Living Trust, u/a dated September 26, 2013, all of the Trust's right, title and interest in the Described Property (together with all after acquired title of the Grantor therein).
- 5. <u>Limitation of Covenants</u>. Grantors expressly limit the covenants of this deed to those expressed herein and excludes all covenants arising or to arise by statutory or other implications.
