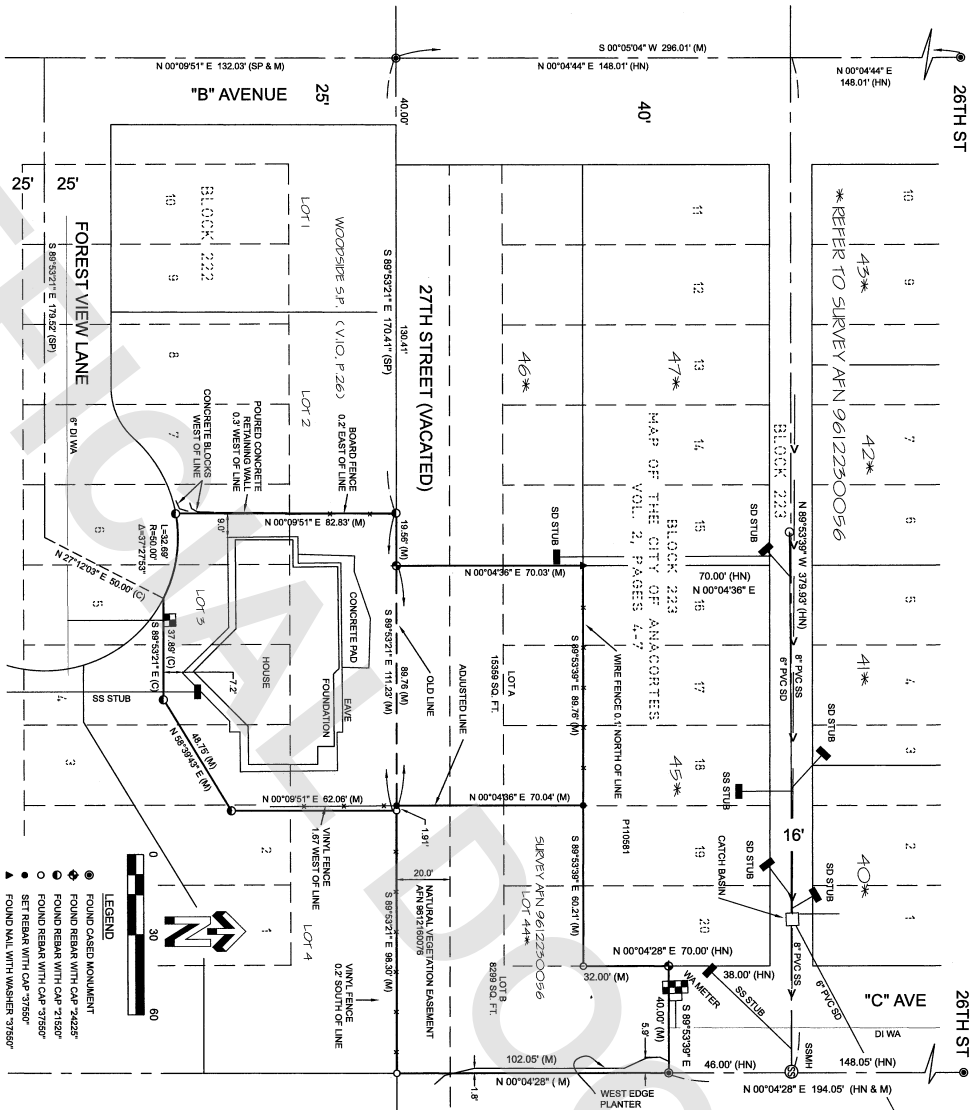


BOUNDARY LINE ADJUSTMENT
