Borrower defaulted on the obligation secured by the Deed of Trust, and as a result, a Notice of Trustee's Sale (the "Notice of Sale") was recorded on January 22, 1998. See Complaint for Declaratory Relief ¶ 13, Ex G thereto. Borrower filed for Bankruptcy protection, however despite the automatic stay, the Trustee Deed Recorded to Wells Fargo Bank, N.A. on May 1, 1998.

Larry L. Dargitz is deceased as of December 6, 2015. Defendant was appointed Personal Representative of Borrower's Estate on June 7, 2017 in Probate case no. 17-4-00225-9. See Complaint for Declaratory Relief ¶ 7, Ex E thereto.

All parties agree that the Trustees Deed Upon Sale should be rescinded and title restored as if the sale had not occurred.

The parties agree that this stipulated order and judgment shall be binding upon and inure to the benefit of the parties, their successors and assigns. The parties further agree that this stipulated order and judgment may be recorded with the Skagit County Auditor, that this is a final order in this case, with each party to bear his, her or its own attorney fees and costs.
