RECITALS:

- A. ULADZIMER PATAPOVICH is the owner of the property bearing Skagit County Assessor's Parcel number: P112366 and P24602, more particularly described in the attached **Exhibit A**.
- B. ILYA & MARIYA PATAPOVICH are the owner of the property bearing Skagit County Assessor's parcel numbers: P24570, more particularly described in the attached **Exhibit B**.
- C. The property owned by the parties are contiguous to each other and the parties simply wish to reconfigure parcels. As such, portions of the property owned by ILYA & MARIYA PATAPOVICH will be incorporated into property owned by ULADZIMER PATAPOVICH; and at the same time portions of property owned by ULADZIMER PATAPOVICH will be incorporated into property owned by ILYA & MARIYA PATAPOVICH. The attached **Exhibit C and D** contain the legal descriptions of the properties to be transferred to each party.
- D. The description of the new boundaries of the properties, as the result of this boundary line adjustment, are set forth in the attached **Exhibits E and F**.
- E. An exhibit map showing the adjusted boundaries of the three parcels is attached as Exhibit G.

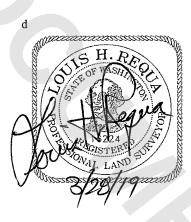
