Corrected MILLING CLAIM 8A CERTIFICATE OF LOCATION OF:

Milling Claim # 8-A, see Map location below. AF No. 201806040139

A Milling area of 10 acres for AARON Mining LLC Claims within approximately 1 mile to the East of this **Milling Claim 8-A**. In addition all Milling area covered under the Mining Act of 1872 and any amendments thereafter and specifically to mill Magnetite, Iron Ore, Gold, Silver, Platinum and all other allowed minerals. **Milling Claim 8-A**, situated in the National Forest Service, Spokane District, Sedro Wooley Skagit County Mining District, Concrete WA area was duly discovered. I Riley D. Evans, acting as Chairman of the Board of **AARON Mining LLC**, a lawful NV and WA Corporation and Citizen of these United States of lawful age do hereby certify and declare as follows to wit: That on and before the 12th day of May A. D. 2018 the Minerals mentioned above were duly discovered.

That on said date this written and printed Notice of Location of said Claims was duly posted conspicuously, at the point of discovery on said claims, which said notice contained the name of the location (which said date of location was the date of the posting of such notice) and the approximate area of the claim intended to be appropriated.

That thereafter and within thirty days of the posting of said notice of location the locator(s) distinctly marked the location of all said claims on the ground, so the boundaries could be readily traced, by placing monuments at each corner and angle of said claim, which said monuments consisting of 4" x 4" White Posts Marked with the 5/12/2018 date of Claim number, claimants name and mailing address and claim corners, information described as follows, to wit: **Beginning at the marked SW corner of Section 29, Township 34 North, Range 8 East, Willamette Meridian, Skagit County WA, Thence to the SE Corner of the North ½ of the SW ¼ of Section 29, Township 34 North, Range 8 East, The true Point of Beginning thence 290.40' North along the center of section subdivision line to the North West Corner of this Claim, thence 90 degrees to the right and East 1,500' to the North East Corner of this Claim, thence 90 degrees South 290.40' to the SE corner of this Claim, thence 90 degrees to the right returning West 1,500' to the True point of beginning and South West corner of this Claim. The West line of this Claim is on the East line of Skagit County Parcel Number 30728 owned currently by Weyerhaeuser Timber Company. This legal description encompasses #8-A Mill and Load Claim 290.4' wide by 1,500 feet long, totaling 435600 square feet, exactly 10 acres.**

That each white painted 4" x 4" post by 4'6" in length so marked with a corner marker numbers as associated on the attached master Claims Map is set in 1' in the ground. That within 60 days after the date of posting said notice of location: The Locator(s) name herein did the following work on said Claim at the point of discovery extracted ore and tested for mining and environmental soils elements, Staked and Set all four corners of each and every Milling Claim corner post. That said locator(s) did there, as a result of said work, disclose the Milling Area so located.
