CAMPBELL, husband and wife, hereby conveys and quitclaims into 210 CARTER, LLC, a Washington limited liability company, the following described real estate, situated in the County of Skagit, State of Washington, together with all after acquired title of the grantor therein:

That portion of the Northeast ¼ of the Northwest ¼ of Section 19,  
Township 35 North, Range 5 East, W.M., described as follows:

Beginning at a point on the North line of the above said subdivision,  
1,640.5 feet East of the Northwest corner of said Section 19;  
thence South 0°03' East parallel to the West line of said Section 19  
to a point which is 135 feet North of the North line of State  
Highway, as said Highway existed on June 11, 1971, and the true  
point of beginning of this description;  
thence South 0°03' East, 135 feet to the North line of said State  
Highway;  
thence North 52°59' East along the North line of said State  
Highway, 130.88 feet;

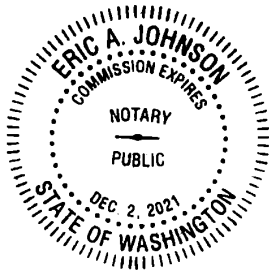
