RESERVATIONS CONTAINED IN VARIOUS DEEDS OF RECORD WHICH MAY BE NOTICE OF A GENERAL PLAN, AS FOLLOWS: 'This deed is made and accepted with the understanding and agreement that no intoxicating liquors shall be manufactured, sold or offered for sale, nor any public dance shall be maintained, conducted or operated at any time on the premises above described in this deed; that any violation of the foregoing agreement shall render this deed null and void and said property shall revert to said Snee-Oosh Land Co., the grantor herein.'
- 2.
