LOAN DEED MODIFICATION AGREEMENT

This Loan Modification Agreement (the "Agreement"), made this May 3, 2019, between Jerod C Barth and Amber M Barth, who acquired title as Jerod Barth and Amber M Barth, husband and wife (the "Borrowers") and BANNER BANK, Successor in interest to Skagit Bank, (Lender), amends and supplements that certain Deed of Trust dated April 18, 2018 and originally recorded on April 23, 2018, as Document No. 201804230098, in Book n/a, at page n/a, in the Official Records of the County of Skagit, State of Washington (the "Security Instrument"), and covering the real property commonly known as follows:

11385 Whitsie Lake Rd, Anacortes, WA 98221

In Consideration of the mutual promises and agreements exchanged, the parties hereto agree to modify the Security Instrument as follows:

- Modify the Maturity date from May 1, 204 to June 1, 2049.
- The Loan balance is \$1,250,000.00.

The Borrowers shall comply with all other covenants, agreements and requirements of the Security Instrument. Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Security Instrument.

Except as otherwise specifically provided in this Agreement, the Security Instrument shall remain unchanged, and the Borrowers and Banner Bank shall be bound by, and comply with all the terms and provisions thereof, as amended by this Agreement, and the Security Instrument shall remain in full force and effect and shall continue to be a first lien on the above-described property. All capitalized terms not defined herein shall have the same meanings as set forth in the Security Instrument.




