
DEED OF RECONVEYANCE



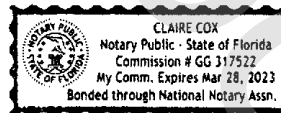
