NOTICE: EASEMENTS AF #201811290002 and AF #201812030186 NOT VALID

The undersigned GRANTORS, John L. Miller Jr and Margaret K. Miller, of that certain EASEMENT dated August 26, 1997, and Recorded under Skagit County Auditor File # 9709080043, do hereby declare that those certain utility Easements Granted by Forrest A. Foss and Cheryl R. Foss, et al, to Whistle Lake, LLC (Grantee), Recorded under Auditor #201811290002, and to Puget Sound Energy, under #201812030186, to be in violation of the Conditions of that governing Easement between GRANTORS John L. Miller Jr and Margaret K. Miller, and GRANTEES John and Jane Wiegand, Howard and Cheryl Rogers, and Forrest Foss, Dated August 26, 1997, and Recorded by Forrest Foss under Auditor #9709080043, to wit:

Millers granted Easement to Foss, et al, subject to the following Conditions and Restrictions which specifically prohibiting extension of utilities to W1/2 SW1/4 SE1/4 S31 T35N R2E WM without **GRANTOR Millers written approval,** which, to date, has not been granted:

"(4) RESTRICTION: This Easement is expressly limited to the appurtenant properties below and is specifically unavailable to the benefit of the West Half of the Southwest Quarter of the Southeast Quarter of Section 31, Township35N, Range 2 E, WM, without the express written consent of the Grantor" and "Any granting of utility easements by Grantees Rogers and Foss, their heirs, successors, and assigns, in favor of the West Half of the Southwest Quarter of the Southeast Quarter of Section 31, Township 35N, Range 2E, WM shall require prior written approval of the Grantor", and "In event grantees Rogers or Foss grant easement without Grantors approval, Grantees Rogers and Foss agree to pay Grantor the sum of Fifty Thousand Dollars (\$50,000)."

Grantee Foss, along with others, subsequently granted Utility Easement to Whistle Lake, LLC, under **AF** #201811290002, and Utility Easement to Puget Sound Energy, under **AF** #201812030186, without the required "expressed written consent of the Grantor" (Miller), a direct violation of Restriction 4 of governing Easement **AF** #9709080043, and without said "written consent of the Grantor" is **not valid**.

John and Margaret Miller are the sole Grantors under Easement AF #9709080043, and have not assigned or transferred Grantors' interest to any other party.

Additionally, Condition (2) of Easement AF #9709080043, requires Grantee (Foss) to construct a water storage tank, and is prohibited from utilizing any existing water storage capacity supplied by existing storage tank located within Fidalgo Bay Addition, to wit:

"(2) Any water storage requirements needed to serve Grantees' properties shall be constructed at Grantees' expense. Grantees shall not use any existing water storage capacity supplied by existing storage tank located within Fidalgo Bay Addition."
