NOTICE OF REAL PROPERTY PERMISSIVE USE

Survey AF#201406180061 (the "Antone Property").

WHEREAS, the Antone Property shares a boundary with the real estate and improvements located at 3918 Rockridge Parkway in the City of Anacortes, Skagit County, Washington, Parcel No. P127680, legally described as Lot 10 of Rock Ridge South Phase 3, AF#200806300185; being a portion of Tract G of Rock Ridge South Phases 1 and 2, AF#200701240094, located in NW 1/4 of the NW 1/4 Section 26, Township 35 North, Range 1 East (the "Rockridge Property");

WHEREAS, as of the date of this Notice, there is an existing encroachment from the Rockridge Property onto the Antone Property along the shared boundary between the two properties as illustrated in the attached Exhibit A, which is incorporated herein by refererence. The encroaching materials include crushed rock, landscaping rocks, bark, and vegetation. On the western portion of the shared border, the encroachment occurs over a length of 27.1 feet extending as much as 2 feet on to the Antone property. On the eastern portion of the shared border, the encroachment occurs over 26.2 feet extending as much as 2.5 feet on to the Antone property.

of the properties.


