This Deed of Trust contemplates that Borrower may repeatedly borrow and repay funds throughout the duration of the term contained in the Open Ended Revolving Credit Agreement and, Borrower may repay said amounts during said term and again borrower additional funds, repeatedly, with credit being extended in the future by Lender up to the maximum amount specified on the first page of this Deed of Trust, and any and all such future advances shall be secured by this Deed of Trust with each advance relating back to the original date of this Deed of Trust.
- 28. Collateral Protection Advances. In addition to any other sum secured hereby, this Security Instrument shall also secure the unpaid principal balance of, plus accrued interest on, any amount of money loaned, advanced or paid by Lender to or for the account and benefit of Borrower, after this Security Instrument is delivered to and filed with the Recorder's Office for recording in the County where the encumbered property is located. Lender may make such advances in order to pay any real estate taxes and assessments, insurance premiums plus all other costs and expenses incurred in connection with the operation, protection or preservation of the Property, including to cure Borrower's defaults by making any such payments which Borrower should have paid as provided in this Security Instrument.
