Surviving Trustee

In the event of the death of either Richard Byington Manning, or Lona Marie Milne Manning, or if for any reason either ceases to serve as Trustee hereunder, the Trustors nominate and appoint the remaining or surviving original Trustee to serve as sole Trustee hereunder without the approval of any court.

Successor Trustee

In the event of the death of the remaining or surviving original Trustee, or if for any reason such person ceases, or is unable, to serve as Trustee hereunder, the Trustors nominate and appoint Linetta S. Milne to serve as Successor Trustee(s) hereunder without the approval of any court.

Alternate Successor Trustees

In the event of the death of the named Successor Trustee(s) or if for any reason one of them ceases to serve as Trustee hereunder, the Trustors nominate and appoint the following to serve as Successor Trustee hereunder without the approval of any court:

Robert M. Manning shall serve in the place of Richard J. Manning.

Charles M. Manning shall serve in the place of Robert M. Manning.

When more than one person is named with others to act as Successor Co-Trustees and one of the named persons is unable or unwilling for any reason to serve or to continue to serve, and no additional persons are named herein to take the place of such Trustee who is unable or unwilling for any reason to serve or to continue to serve, the Settlors direct that the remaining named Successor Co-Trustee(s) shall continue to serve as Co-Trustees (or if only one remains, Trustee) hereof without the approval of any court.
