# THIRD AMENDMENT TO DECLARATION OF COVENANTS FOR SKYLINE COURT **CONDOMINIUM**

**PURPOSE:** 

TO CHANGE PERMITTED USES TO PROHIBIT SMOKING

AND VAPING.

THIS AMENDMENT is made this 15th day of October, 2019, by the Skyline Court Condominium Owners Association (the "Association").

#### WITNESSETH THAT:

WHEREAS, a certain Plat Map establishing Skyline Court Condominium was recorded by its Declarant among the land records of Skagit County, Washington, at Auditor's file No. 199204160064, contemporaneously with a Declaration and Covenants, Conditions, Restrictions, and Reservations (the Declaration) benefiting and burdening all of the Units of Skyline Court Condominium, which Declaration was recorded at Auditor's file No. 1999204160065; the Declaration was amended by the recording of the First Amendment to Declaration at Skagit County Auditor's File No. 199206240092; and Second Amendment to Declaration at Skagit County Auditor's File No. 199212100086; and

WHEREAS, pursuant to Section 28 Article 28.2.2 of the Declaration, restricted uses of Units can be adopted by a vote of 90 percent of the Owners; and

WHEREAS, the Skyline Court Condominium Owners voted by a 90 percent majority to prohibit smoking and vaping in Units, Common Elements, and Limited Common Elements.

NOW, THEREFORE, pursuant to and in compliance with RCW 64.34.264 and Article 28.1 of the Declaration, the following Definitions and Sections are added to the Declaration for Skyline Court Condominium:

#### ARTICLE 1, DEFINITIONS, SECTION 1.1, WORDS DEFINED

Smoking shall mean carrying, burning, or otherwise handling or controlling any lit or smoldering product containing tobacco, nicotine or cannabis, including but not limited to cigarettes, cigars, pipes or bongs.

<u>Vaping</u> shall mean the act of inhaling and exhaling an aerosol produced by an ecigarette, vaporizers, vape pens, hookah pens, electronic cigarettes (e-cigarettes or ecigs), and e-pipes or similar device.

## ARTICLE 11, SECTION 11.9.1

Section 11.9.1 <u>No Smoking</u>. No smoking shall be allowed in any Unit, any Limited Common Element, or any Common Element.

## **ARTICLE 11, SECTION 11.9.2**

Section 11.9.2 No Vaping. No Vaping shall be allowed in any Unit, any Limited Common Element, or any Common Element.

EXCEPT as modified by this Third Amendment, all of the terms and provisions of the governing documents are hereby expressly ratified and confirmed and shall remain in full force and effect.
