Borrower reaffirms all the terms and conditions of the Deed of Trust and said terms and conditions are incorporated in this Amendment as if fully set forth herein. Borrower, as grantor, hereby grants, bargains, sells and conveys to the trustee of the Deed of Trust, in trust with power of sale, the real property therein described, as security for the Note, as amended, and the Loan Agreement, as amended.
