# COMMUNITY PROPERTY SURVIVORSHIP AGREEMENT RCW 26.16.120

## **PARTIES**

The parties to this Agreement are James Henry Webster ("husband" herein) and Karin Irmgard Webster, ("wife" herein), residents of Seattle, King County, State of Washington.

#### RECITAL

Husband and wife have acquired certain community property within the State of Washington and desire to avail themselves of the provisions of RCW 26.16.120. If the husband and wife currently have or hereafter acquire any separate property, they each declare that all such property shall be deemed community property and shall be subject to the provisions of this Community Property Survivorship Agreement. Each party further declares that all community property shall at the death of either of them then vest in the surviving spouse. This agreement is not intended to affect other spousal agreements dealing with, *inter alia*, how their property is to be managed in the event legal proceedings concerning their marital community ever should be commenced.

#### **AGREEMENT**

NOW, THEREFORE, in consideration of the mutual benefits to be derived by the parties hereto, it is agreed as follows:

All community and separate property of whatever nature or description, whether real, personal or mixed, and wherever situated now owned or hereafter acquired by them, or either of them, shall be deemed community property and, at the death of either of them, become the

property of the surviving spouse; provided, if the survivor disclaims the right to take any portion of any interest governed by this community property agreement, then such disclaimed portion shall pass under the terms of the decedent spouse's Last Will and Testament in effect as of the date of his or her death.

In the case of the death of said husband while the said wife survives him, all community real property shall at once vest in the said wife in fee simple. In the case of the death of said wife while said husband survives her, all community real property shall at once vest in said husband in fee simple.
