I, Don McDermott, Sheriff of Skagit County, State of Washington, do hereby certify that a ORDER OF SALE did issue out of the Superior Court of SKAGIT County, Washington, on September 11, 2018, upon a judgment rendered in Superior Court of SKAGIT County, Washington on August 20, 2018, in favor of CAPE HORN MAINTENANCE CO., A WASHINGTON NONPROFIT CORPORATION, for the sum of Five Thousand Eight Hundred Twenty Three Dollars and Fifty Seven Cents (\$5,823.57).

The ORDER OF SALE, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on September 14, 2018, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the ORDER OF SALE.

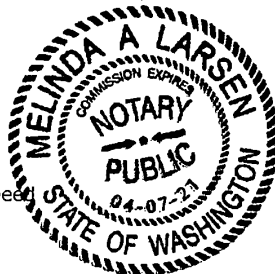
