DEED OF RECONVEYANCE





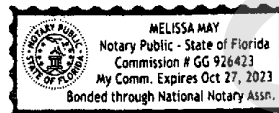
