## INSTRUCTIONS FOR OWNER OCCUPANCY COVENANT

The Cover Sheet, Covenant and Exhibit A must comply with the Skagit County Recording Division "Documents Standards Guide". These requirements can be found at <a href="https://www.skagitcounty.net/Departments/AuditorRecording/RecordingStandards.htm">https://www.skagitcounty.net/Departments/AuditorRecording/RecordingStandards.htm</a>.

Outlined below are some of the basic requirements:

- 1. Type or print clearly in black ink and have a clear 1-inch border on all four sides.
- 2. Complete the Washington State Recorder's Cover Sheet. List your project number as the "Reference Number" and list all owners as the "Grantor(s)". Fill in the abbreviated legal description and the tax parcel number.
- On the first page of the Covenant for Owner Occupancy, fill in the full legal name of all the owners on the first blank line and the complete street address of the property on the second blank line.
- 4. Each owner must sign the bottom of page 1 in the presence of a Notary Public, and have the Notary complete page 2. If there are more than two owners, make copies of page 2 and have the Notary complete them as needed.
- 5. Type or clearly print in the box on Exhibit A the full legal description of the property.
- 6. Prior to recording, bring the covenant to PCED for review by the planner associated with your project.
- Bring the reviewed covenant to Skagit Count for recording and return a copy of the recorded document with recording number stamp to PCED to receive your permit.
