The undersigned subordinator and owner agrees as follows:
1. iQ Credit Union referred to herein as "subordinator," is the owner and holder of mortgage dated 01.03.2020 which is recorded in volume of Mortgages, page under auditor's file No. 202001030101 records of Skagit
County.
2. iQ Credit Union referred to herein as "lender," is the owner and holder of a mortgage dated July 29, 2020 executed by Jeff R. Beltramini and Jennifer M. Beltramini, husband and wife
(which is recorded in volume records of 20200805 0019 Skagit county) (which is to be recorded concurrently herewith).
3. Jeff R Beltramini and Jennifer M Beltramini described in the mortgage identified above in Paragraph 2.
4. In consideration of benefits to "subordinator" from "owner," receipt and sufficiency of which is hereby acknowledged, and to indus "lender" to advance funds under its mortgage and all agreements in connection therewish, the "subordinator" does hereby unconditional autordinate the lien of his mortgage identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above and all advances or charges made or accraing there under, including any extension or renewal thereof.
