**PARCEL A:**

Lots 1 through 9, inclusive, Block 192, PLAT OF FIDALGO CITY, according to the plat thereof recorded in Volume 2 of Plats, pages 113 and 114, records of Skagit County, Washington;

**PARCEL B:**
