RECITALS

- Grantor/Grantee is the owner of real property legally described in Exhibit A-1, A. the "Servient Parcel" encumbered by the easement dedicated herein attached hereto and incorporated herein by this reference.
- Grantee is also the owner of real property legally described in Exhibit A-2 the "Dominant Parcels," benefitting from the easement dedicated herein and attached hereto and incorporated herein by this reference.

C. Grantor has determined that it is in its best interest to dedicate a non-exclusive perpetual easement for ingress, egress, and utilities over, under, and across a strip of legally described in Section 1 below..

NOW, THEREFORE, the Grantor hereby dedicates the following non-exclusive easement:

- 1. <u>Dedication of Easement</u>. Grantor hereby dedicates and grants to Grantee, without warranty, a non-exclusive, perpetual easement for ingress, egress, and utilities, over, under, and across a portion of Lot 53 and Lot N of Amended Skagit Regional Airport Binding Site Plan, Phase 1, Auditor's File No. 200303040030 (the "Easement Area") and being more particularly described in **Exhibit A-3** and attached hereto and incorporated herein by this reference
- 2. <u>Intent of Easement</u>. The intent of this easement is to provide access from the west edge of Higgins Airport Way right-of-way to benefit the Dominant Parcels lying westerly thereof.
- 3. <u>Use of Easement</u>. The Grantor/Grantee and any tenant of the Grantor/Grantee, including employees, agents and invitees thereof, may use the easement in a reasonable manner that does not interfere with the use of the easement area by any tenant of either the Dominant Parcels or the Servient Parcel. Grantor/Grantee shall have exclusive authority to approve the placement, or to place, improvements in the easement area consistent with the terms hereof.
- 4. <u>Site Map</u>. A map showing the Easement Area, the Servient Parcel and the Dominant Parcels is attached hereto as **Exhibit B** and incorporated herein by this reference.
- 5. <u>Non-Waiver of Breach</u>. The failure of Grantor to insist upon strict performance of any of the covenants or agreements of this easement in one or more instances shall not be construed to be a waiver or relinquishment of any such covenant or agreement, but the same shall be and remain in full force and effect during the term of this easement.
- 6. <u>Easement Runs with Land</u>. The benefits, burdens, and covenants of the easement granted herein shall be deemed to be appurtenant to and run with the land and shall bind the Grantor's/Grantee's Property, the Grantor/Grantee, and all entities and persons possessing the properties subject hereto.
- 7. <u>Applicable Law</u>. This Agreement shall be construed according to the laws of the State of Washington.
