FINAL ORDER OF VACATION

WHEREAS, the Board of Skagit County Commissioners, having on the 25th day of November, 2019, signed R20190207 to call for a Public Hearing, and

WHEREAS, on the 1st day of December, 2019, signed R20190234 to order the vacation of a portion of said County right-of-way known as South Healy Road, County road #94230, and

WHEREAS, payment by the principal petitioner of all remaining costs and expenses incurred in the proceedings, with said costs and expenses amounting to the sum of \$975.00 now having been received by the Treasurer's Office of Skagit County.

NOW THEREFORE, BE IT RESOLVED AND IT IS HEREBY ORDERED by the Board of Skagit County Commissioners to vacate County right-of-way known as South Healy Road, County Road #94230, as petitioned by Terry Smith representing Western Reman Company, described as follows:

All of the previously undescribed County Road known as South Healy Road, No. 94230, as originally located and constructed upon over and across Section 15 and 16, Township 35 North, Range 6 East, Willamette Meridian.

Said road beginning at the south margin of Lyman-Hamilton Road, No. 94020, in the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 15, and generally running south, lying west of and generally parallel to Etach Creek, through the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 15 and the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 16.

Thence, continuing south to a point described in Volume 31 of Deeds, Page 695, Records of Skagit County, Washington. Said point being described as the center of a 40 foot wide strip of land, running west. Said strip of land described as lying on the South side of the line of the nearest legal subdivision of Government Survey of Section 16 and it's intersect with County Road, known as South Healy Road.

Said subdivision line being the South line of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 16, Township 35 North, Range 6 East, Willamette Meridian.

Situate in the County of Skagit, State of Washington.
