Massey (whose address is 600 Pakis Apartment 12, Hot Springs, AR 71913), and Hanora M. Lay (whose address is 716 North Crystal Springs Road, Royal, AR 71968). The signature of one Trustee is sufficient to exercise the powers of the Trustee.
- 3. The tax identification number of the trust is the Social Security number of Billie J. Massey.
- 4. Title to assets held in the trust will be titled as:
 - Billie J. Massey, Schevaun R. Massey, and Hanora M. Lay, Trustees, or their successors in interest, of the Billie J. Massey Family Trust dated March 3, 1992, and any amendments thereto.
- 5. An alternative description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.
- 6. Excerpts from the trust document that establish the trust, designate the Trustee, and set forth the powers of the Trustee will be provided upon request.
