the undersigned subordinator and owner agree as follows:

- 1. Peoples Bank, A Washington Corporation referred to herein as "subordinator", is the owner and holder of a <u>Deed of Trust</u> dated <u>April 6, 2020</u> which was recorded on <u>April 9, 2020</u> under auditors file No <u>202004090073</u> records of <u>Skaqit County</u>, <u>Washington</u>.
- 2. <u>Peoples Bank, A Washington Corporation</u> referred to herein as "lender", is the owner and holder of a Deed of Trust dated <u>11-16-2020</u>, executed by <u>Bret Thornton and Ingrid Thornton, husband and wife,</u> which is recorded under auditor's file No. <u>202011250077</u> records of <u>Skagit County,</u> <u>Washington</u> (which is to be recorded concurrently herewith).
- 3. Bret Thornton and Ingrid Thornton, husband and wife, referred to herein as "owner", is the owner of all real property described in the mortgage identified above in paragraph 2.
- 4.
