

- c. All "Proceeds" and Assets owned by Borrower as such term is defined in the Uniform Commercial Code as the same may from time-to-time be in effect in the Commonwealth of Washington (the "Code").

EXHIBIT "B" LEASES & RENTS

CONTRACTS, PLANS, PERMITS, & APPROVALS
