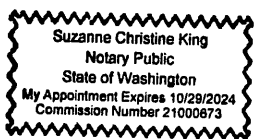

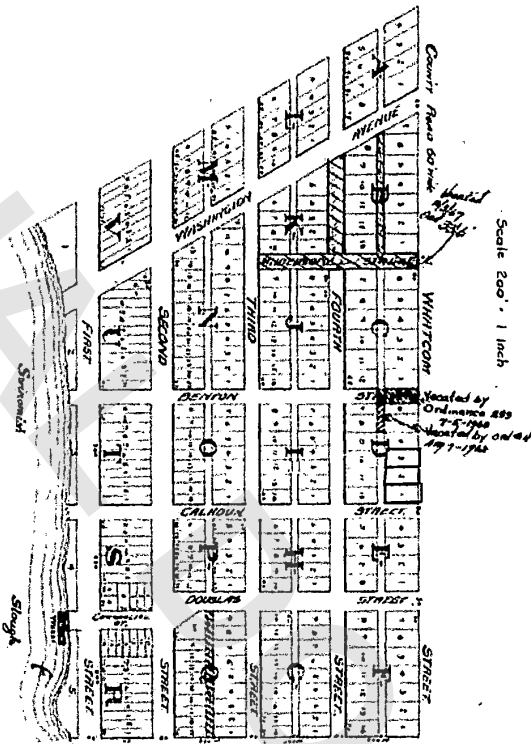
MAP OF LACONNER
