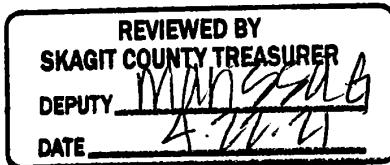

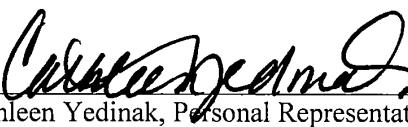
5 Begin at the Southwest corner of Tract "A" of Skagit County Short

26 allow equipment entry, then the cost to improve, widen or extend any portion thereof
27 will be at the expense of the property owner requiring the revisions, modifications or
28 widening of said entry or driveway.
