Said deed of trust encumbers the following property:



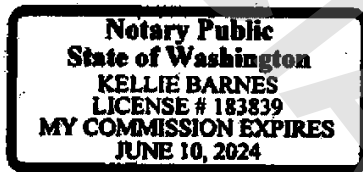
