NOTICE OF GRANT REQUIRMENT

Skagit Land Trust, a Washington not for profit corporation, is the owner of a certain real property located in Skagit County, Washington, by Statutory Warranty Deed recorded under Skagit County Auditor's File Number 201902150069, more particularly described in Exhibit "A" for this NOGR as the "Property" being that approximate 10-acre portion lying south of the road identified on the short plat of Auditor file 201902150064 as "Lot 2 (South) of Government Lot 4 of Section 36, Township 36 North, Range 2, W.M. in GL 4 of Sec. 36, Twp. 36 N., R. 2 E. and attached hereto and made part of hereof (the "Property").

Skagit Land Trust acquired the Property partially with North American Wetlands Conservation Act funds and partially with match funds, pursuant to a Grant Agreement between the U.S. Fish and Wildlife Service and Skagit Land Trust, dated August 20, 2019, Agreement Number: F19AP00690, a copy of which is kept at the Division of Bird Habitat Conservation (DBHC), U.S. Fish and Wildlife Service, 1849 C Street NW, Washington, DC 20240 and at the office of Skagit Land Trust at 1020 3rd Street, Mount Vernon, Washington 98273.

The Property was conserved in order to permanently protect, enhance, and restore approximately 10 acres of freshwater emergent wetlands, marine estuarine wetlands and forested uplands and associated habitat for the benefit of waterfowl, migratory birds, fish, wildlife, native plant communities, and wildlife viewing.

Skagit Land Trust hereby agrees to be bound by the terms of the Grant Agreement as they relate to the Property, including the obligation to ensure the long-term conservation of the Property and to obtain the consent of the U.S. Fish and Wildlife Service DBHC prior to the conveyance or encumbrance of any interest therein. If any interest is converted, sold, conveyed, or otherwise encumbered, an attributable share may be owed to DBHC.

The terms of this Notice shall be binding upon Skagit Land Trust and its designees and successors.
