the undersigned subordinator and owner agree as follows:

- Peoples Bank, A Washington Corporation referred to herein as "subordinator", is the owner and holder of a <u>Deed of Trust</u> dated <u>September 4, 2019</u> which was recorded on <u>September 6, 2019</u> under auditors file No <u>201909060095</u> records of <u>Skagit County, Washington</u>.
- 2. <u>Peoples Bank, A Washington Corporation</u> referred to herein as "lender", is the owner and holder of a Deed of Trust dated <u>Dec. 17, 2021</u>, executed by <u>Lori Gearhart, as her separate property and Jonathan Gearhart, as his separate property, which is recorded under auditor's file No <u>202201050039</u> records of <u>Skagit County, Washington</u> (which is to be recorded concurrently herewith).</u>
- 3. Lori Gearhart, as her separate property and Jonathan Gearhart, as his separate property, referred to herein as "owner", is the owner of all real property described in the mortgage identified above in paragraph 2.
- 4. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his mortgage identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or charges made or occurring thereunder, including any extension or renewal thereof.
