## Utility Easement from Joshua and Rebecca Top to John L. Bouslog

A 20.00 foot wide easement for utility purposes over under and across a portion of the Southerly 3/4 of the Southwesterly extension of "E" Street lying Southwesterly of the Southwesterly right-of-way margin of First Street as shown on the plat of "Addition to Bay View, Wash. (Seigfred's)" as per plat recorded in Volume 1 of Plats, page 11, records of Skagit County, Washington being 10.00 feet left (Southeasterly) and 10.00 right (Northwesterly) of the following described centerline:

BEGINNING at the Northerly most corner of Lot 8, Block 5 of said "Addition to Bay View, Wash. (Seigfred's)"; thence North 20°43'34" West along the Westerly right-of-way margin of First Street for a distance of 45.00 feet to the Northerly line of the Southerly 3/4 of said extension of "E" Street; thence South 68°58'20" West along said Northerly line for a distance of 70.7 feet, to the TRUE POINT OF BEGINNING of said centerline; thence South 9°03'45" East for a distance of 46.00 feet, more or less, to the Southeasterly margin of said Southwesterly extension of "E" Street, also being the Northerly line of said Lot 8, Block 5, plat of "Addition to Bay View, Wash. (Seigfred's)" and being the terminus of said centerline.

SUBJECT TO and TOGETHER WITH easements, reservations, restrictions, covenants, liens, leases, court causes and other instruments of record.

Situate in the County of Skagit, State of Washington.

The intent of this easement is to be centered along the existing utility line/lines in support of the drainfield for easement recorded under Skagit County Auditor's File Numbers 9307020144 and 9307060040. If at such time it is found that the utility lines run at a different alignment, the easement is to follow said centerline and adjusted as necessary.
